ANNEX 1: TERMS OF REFERENCE

BACKGROUND INFORMATION

Norwegian Church Aid (NCA) is an independent humanitarian organisation that works with partner organisations in their struggle to eradicate poverty and injustice. We provide emergency assistance in disasters, work for long-term development in local communities and address the root causes of poverty, we advocate for just decisions by public authorities, business and religious leaders. As one of the Nordic region's largest aid organisations, we are headquartered in Oslo, Norway. We are present in about 20 countries worldwide, and with presence in Ethiopia over 50 years. Regarding the property NCA holds in Kirkos, Addis Ababa, covering 4,653 m² land, NCA intends to develop the property by constructing a mixed-use facility in partnership with a business entity that will provide construction funding through equity injection. To further proceed in this venture, a strategic advisor will be contracted.

CONTRACT PURPOSE AND EXPECTED RESULTS

Overall objective:

To successfully plan the development of the property in Addis Ababa together with equity partner(s) to secure a future cashflow (NCA's share) to support the development and humanitarian activities in Ethiopia.

Purpose:

Support NCA in providing strategic advice and identifying long term equity partner(s) to initiate and complete the planning of the property development project. The equity partner(s) must have a long-term perspective aligned with NCA's ambitions and values.

Results to be achieved by the Contractor:

- 1. Concept note, financial model and investor presentations
- 2. Identify equity partners with proof of funding capability
- 3. Financial structure, including governance framework
- 4. Closing of transactions with chosen equity partner(s)

SCOPE OF THE SERVICES

- 1. Strategic Advisory and Investor Outreach:
 - Developing and executing a comprehensive investor outreach strategy targeting both strategic and financial investors.
 - Conducting thorough due diligence on potential investors, preferably targeting long-term partner(s).
 - Preparing high-quality marketing materials, including a Concept Note, financial model, and investor presentations.
 - Managing the investor due diligence process, responding to inquiries, facilitating site visits, and coordinating with NCA's legal counsel.
 - Negotiating key terms and conditions of the joint venture / investment agreement, including equity splits, land valuation, risk sharing (e.g. on capital expenditure overrun, delays, cash flow from tenants, possible loan exposure and other liabilities) and project governance alongside NCA.
 - Facilitating the closing of the Transaction and ensuring all necessary legal and financial documentation is executed.

2. Project Development and Structuring:

- Advising on the optimal legal, financial, governance and operational structuring of the project, including joint venture structures, land transfer mechanisms, and financing options.
- Coordinating with NCA's legal counsel and other advisors.

The Contractor will report to the Director of Finance in NCA.

Reporting on progress is expected bi-weekly in a written note. A different frequency can be decided as required.
